

### Information for Confirmation Recipients

Enclosed is the Confirmation of receipt of your Pesticide Use Notice issued by authority of the Administrator under the British Columbia *Integrated Pest Management Act* Section 7.

This Confirmation is effective until the expiration date noted on the Confirmation.

Requirements for Confirmation holders are specified in the BC *Integrated Pest Management Act* and Regulation that came into force on December 31, 2004.

The Act and regulations can be viewed at the Ministry of Environment's IPM Program web site at the following address: <http://www.env.gov.bc.ca/epd/ipmp>. You can also locate this web page by going to the BC Government web site at [www.gov.bc.ca](http://www.gov.bc.ca) and typing 'IPM Program' in the search function.

Requirements for the use of pesticides under a Confirmation include, but are not limited to, the following referenced sections of the Integrated Pest Management Regulation (IPMR).

- An annual notice of intent to treat (NIT) must be provided to the ministry at least 21 days prior to pesticide use in each year of the Confirmation in accordance with **Section 42**, including;
  - (a) the name and business location of the confirmation holder;
  - (b) a description of the proposed treatment locations for the calendar year and a map or diagram that clearly identifies those locations;
  - (c) a description of the proposed treatment for each treatment area including the pesticide to be used and its method of application;
  - (d) the total area of treatment areas in the treatment locations described under paragraph (b)
- Increases of up to 10% of the total treatment area on the NIT require written notice to be provided to the ministry at least 2 business days before using the pesticide under **Section 42(4)**. Increases in area greater than 10% require a revised NIT to be submitted 21 days in advance according to **Section 42(5)**. Revised NIT's must be for use within areas identified in the Pesticide Use Notice.
- Please provide the NIT's and revised NIT's to the appropriate Regional Office(s) of the Ministry of Environment (listed below).
- A detailed map or diagram showing treatment areas, no-treatment zones and pesticide-free zones must be prepared for each of the treatment areas identified in the NIT. These must be retained and may be requested by a ministry inspector. A map that identifies the locations of the treatment sites must be submitted with the NIT according to **Section 42(3)(b)**.



- Notification must be provided to individuals in the vicinity of a treatment location in accordance with **Section 28**.
- If the information on the Pesticide Use Notice changes the applicant must submit an amended Pesticide Use Notice and obtain an amended confirmation that the ministry has received the amendment according to **Section 59 (2)**. Please note that according to **Section 27 (2)** changes to certain attributes of a Pesticide Use Notice (i.e. prescribed use, geographic boundaries, active ingredients) will require public consultation under **Section 61** before submitting the amendment.
- Records of pesticide use must be kept daily in accordance with **Section 37** and **83**.
- An annual report of pesticide use, including maps, must be provided to the administrator by January 31 of the following calendar year according to **Section 39**.
- Confirmation holders must ensure compliance with the applicable regulations for storage, transport and use in **Sections 65 to 82**.

The *Integrated Pest Management Act* **Section 7** requires keeping the pest management plan at the location identified on the Pesticide Use Notice, producing it without charge to any person who requests it for inspection and providing copies if requested (the maximum charge for copies is set by IPMR **Section 30** at \$0.25 per page).

Additional industry sector review papers that summarize requirements for each major pest management sector are posted at the IPM Program web site listed above. These summaries list regulations pertaining to pesticide vendors, landscape and structural pests, forestry, industrial vegetation and noxious weeds, railways and mosquitoes.

Please review the sector review paper appropriate to your industry sector to ensure that you will be in compliance with requirements.

Forms for records of use and for annual summaries of use are also posted on the IPM Program web site.

Please send amended Pesticide Use Notices to the Victoria address shown on the Confirmation.

## Report Pesticide Problems

### Coughing? Skin rash? Vomiting?

Have you, your pets or your livestock ever had any of these problems after using pesticides? Then you may have experienced a pesticide incident. If so, it's important that you report it to Health Canada or the pesticide company.

### What is a pesticide incident?

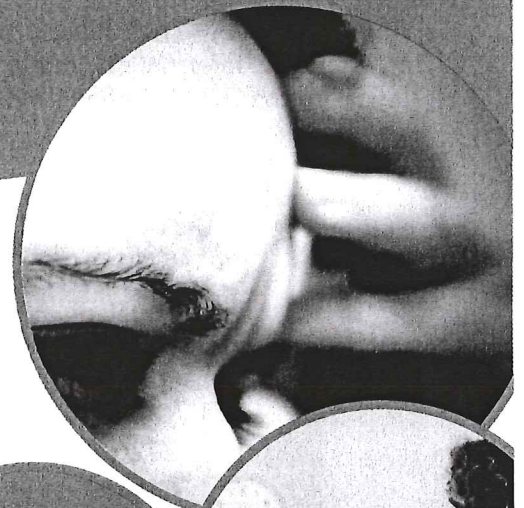
A pesticide incident is a negative effect to humans, animals or the environment that can result from being exposed to a pesticide. Common types of pesticide incidents include:

- effects to humans (e.g. skin rash or headache),
- effects to a pet or a farm animal (e.g. vomiting),
- effects to the environment (e.g. dead fish or birds), or even
- problems with pesticide containers.

### How do I report a pesticide incident?

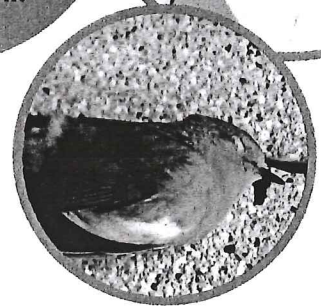
There are two ways to report them:

1. Contact the pesticide company using the information on the product label. They are required by law to report all incidents related to their products to Health Canada.
2. Go to [www.healthcanada.gc.ca/pesticideincident](http://www.healthcanada.gc.ca/pesticideincident) and fill out one of the forms under the section called "How to report a pesticide incident." 


## Why do I need to report pesticide incidents?


Health Canada is in charge of registering pesticides in Canada. Reporting problems helps Health Canada identify possible unexpected issues. For example; if an issue related to the eyes is identified with the use of a pesticide, Health Canada may add a condition to the product label requiring the use of protective glasses.

Health Canada will not contact your employer. You do not need to provide Health Canada with any personal information (name or address) when you report an incident. You may view the report on the Health Canada website.
